TERMS & CONDITIONS FOR REPRODUCTION

I. Requests - To request images, the applicant must complete and sign this form and fax/mail it along with the Images Request form (3 pages). Requests are reviewed by staff to determine the Museum's participation in the project or its approval of the requested use for the image(s).

II. Materials - The Museum does not supply images to rental and/or sales services. Prints and digital image files are provided to the applicant for only the purpose expressed in the Image Request form. Low resolution digital image files are provided for study, classroom presentations, powerpoints and research purposes only and may not be used for other adaptations, transmissions or reproductions.

III. Fees - Unless special arrangements have been made prior to making the request, both production and use fees are payable in advance and should accompany the completed forms, whether or not the image is used or reproduced. To pay by credit card, please complete our Credit Card Information form and include it with the forms. Personal/research uses of images are exempt from use fees. Failure to pay means use permission has not been granted. If images are not used, the use fees may be refunded upon receipt of a written request. Fees for prints sales are non-refundable. All requests for reuse or change in use must be applied for in writing. Use fees are waived when images are used in publications, moving images productions, and media releases solely to promote and publicize the Museum's collections, activities, and exhibitions. Foreign applicants must pay all invoiced charges with funds drawn on a U.S. bank in U.S. dollars and with no deduction of bank fees.

IV. Permission - Permission to use an image includes one-time, one use, non-exclusive, single language, world-wide publication rights. Additional languages and subsequent editions, additional markets and media constitute reuses or changes in use and will be considered upon application. Exclusive rights are not granted to any applicant. Exhibition use refers to exhibits in museums and schools. Display use refers to the display of images in offices, commercial organizations, restaurants, and other public spaces. Regarding internet, CD & DVD-ROM and software use, permission is granted to the applicant provided that they are sufficiently secure to prevent unauthorized downloading, transferring, copying and manipulation of content with specialized technologies utilized for digital image protection. All digital images will be protected by at least one of the following means: a) download, print, save as, copy, paste functions disabled; b) watermarking the credit line near bottom edge, or directly alongside or under each image; c) file encryption; and d) commercial intellectual property software. Permission may not be reused, transferred, assigned, sold, or otherwise disposed of without written permission of the Museum. Images can not be used as endorsements for commercial products. If use has not occurred before two (2) years has passed, permission is automatically revoked and must be requested again. The Museum reserves the right to refuse to grant permission to any applicant whose project and product are not acceptable to the Museum for any reason. Permission has not been granted until fees have been paid. Images may not be copied, scanned, exhibited, resold or used for any other purpose than that specified in this agreement. Copies shall not be deposited in another library, archives, or repository.

V. Image - An image of art must be reproduced unaltered and in its entirety on all or part of a single page unless otherwise approved by the Museum. The reproduction must be full-tone black and white or full color and may not be cropped, bled off the page, printed on color stock, nor have anything overprinted or superimposed on it. When a detail is used, the word "Detail" must appear in the caption with the complete credit line. Detailing may be approved only if the entire artwork is shown elsewhere in the publication or production. Non-art images may be cropped upon request, otherwise full-framed prints or digital images are produced.

VI. Credit Line - The credit line should generally include: Artist/photographer, title, date, medium, catalog number, collection name, National Cowboy & Western Heritage Museum, Oklahoma City, OK, unless otherwise noted on agreement and must appear on the same page as the reproduction, the opposite page, or the reverse. For motion pictures, CD ROMs, DVDs, documentaries, etc. include the credit with the listing of other "Sources" or in an accompanying manual.

VII. Gratis Copy - The applicant agrees to provide the Museum with one complete complimentary copy of the publication or production in which the image(s) is/are reproduced.

VIII. Copyright Restrictions Warning - The copyright of the United States (Title 17, U.S. Code) governs the making of photocopies or other reproductions of copyright material. Under certain conditions specified in the law, libraries and archives are authorized to furnish photocopies or other reproductions of copyrighted work. One of these specified conditions is that the photocopy or reproduction is not to be “used for any purpose other than private study, scholarship, or research.” If a user makes a request for, or later uses, a photocopy or reproduction for purposes in excess of “fair use,” the user may be liable for copyright infringement. The granting of permission to publish by the Museum does not absolve users of material images from securing permission from copyright owners and payment of such additional fees as the owners may require, if the Museum does not own copyright or if the original material is not in the public domain. Applicants assume all responsibility for questions of copyright and invasion of privacy that may arise in the use of material images reproduced by the Museum. The Museum may request that the applicant deliver in writing the copyright holder’s permission to reproduce the image before the Museum delivers the image.

IX. Disclaimer - The Museum makes no warranties or representations and assumes no responsibility or liability for any claims against the applicant or the Museum by persons or parties because of a reproduction. Applicant agrees to indemnify the Museum and hold it harmless against any and all such claims. It is the responsibility of the applicant to obtain necessary permissions for those items/materials for which the Museum does not own the copyright or for which other restrictions may apply. Applicants are advised that obtaining rights clearances may be a lengthy and complex task and should be planned well in advance. Any and all royalty payments or other requirements specified by the copyright owner must be paid or honored by applicant.

The applicant is permitted to use the image(s) as described on the Image Request form provided the applicant, by signing below, agrees to all terms and conditions enumerated here and agrees to pay the Museum all expenses shown on the Image Request form.
