

Small Works, Great Wonders Winter Art Sale FIXED-PRICE PROXY



The National Cowboy & Western Heritage Museum is hosting a reception and fundraiser featuring works from Prix de West and other select artists. The sale will feature smaller Western works of art with an emphasis on winter themes.

Proxy bidding is available to Patrons who are unable to attend the sale. Attached is a proxy form to place a bid on artwork at the set price. Each person placing a bid must purchase a bid/ballot book (cost per book is \$50.00 for Museum members, \$60.00 for non-members). A bid book will be charged to you prior to the beginning of the sale.

Proxy bids will be placed on your behalf on Friday, November 18. If you want to bid on one piece, list that artwork on the proxy form with the other pertinent information. If you decide to bid on 2 or more pieces of art, list all pieces on the proxy sheet with specific instructions of your intent to purchase. You must be specific whether you want all or only certain pieces. **IT IS UNDERSTOOD THAT IF MORE THAN ONE ARTWORK IS LISTED AND YOU ARE DRAWN ON ALL, YOU ARE PURCHASING ALL ARTWORKS UNLESS OTHERWISE INSTRUCTED IN WRITING.**

Example: Rank the items you wish to purchase:

In this case, you must indicate whether you want both, or if you get #1 that you do not want #2 and so forth. Three names are selected during the sale and posted. The first person drawn has 30 minutes to confirm the sale. A horn will blow to mark the end of 30 minutes. If the first person chosen does not purchase, then the second person can confirm the sale, etc.

Proxies must be received by NOON Friday, November 18. Fax the proxy form to 405-478-4714 or email to mcreighton@nationalcowboymuseum.org. Be sure to provide phone number or email where you can be reached on the day of the sale.

You will be notified immediately after the sale if you are successful in your bid. All artwork will be shipped shortly after the conclusion of the sale, but no sooner than November 28. However November 22-December 9
